

## Fees for Möbelfakta from 1 Jan 2026

Version 2026-01-01

The following fees apply for Licensee's right to use Möbelfakta under License agreement on right to use Möbelfakta. All fees are stated in Swedish Crowns (SEK) and excluding VAT.

### ANNUAL FEES

The following fees apply to approved companies that declare products with Möbelfakta.

#### 1. Annual fee for license\* per calendar year, based on the following information regarding the Licensee:

#### 2. Annual fee per approved möbelfakta declared product:

\*The annual fee for license and annual fee per Möbelfakta-declared furniture, items 3 and 4 above, amounts to a maximum of SEK 82 160 per year. The annual fee is invoiced at the beginning of the year.

### FEES FOR NEW COMPANIES

The following fees apply to new companies that are going to start declaring products with Möbelfakta.

#### 3. Start-up fee, is paid for a new company that wants to start declaring products with Möbelfakta and includes training\*:

Post-audit completion and deviation management (on-site audit or document review). If the Licensee does not submit the requested documentation collected at the specified times or if the documentation is deficient and needs to be supplemented:

Charged on an ongoing basis	SEK 1 560 per hour excl. VAT.

*1/1 – 31/3: Full annual fee*

*1/4 – 30/6: 75 % of the annual fee*

*Prices will be adjusted for the following year according to SCB:s Services Producer Price Index (TPI). The new fees are based on the annual change for Q3 of the current year compared with the previous year.*

*In the event of differences between the Swedish and English versions of Fees for Möbelfakta, the Swedish version applies before the English version.*
